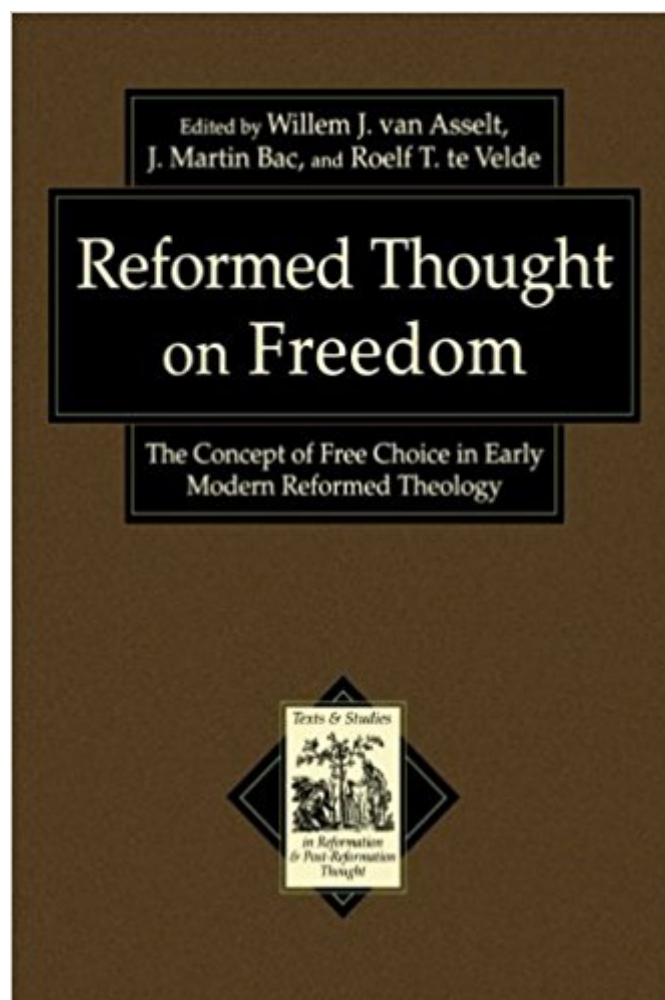

Synopsis

This book makes a major contribution to historical scholarship on the problem of free choice and to contemporary debates over determinism and divine foreknowledge of future events. It fills a significant gap in Reformed knowledge by presenting sources in translation and commentary on works of major importance to the Protestant tradition that have been neglected for centuries. The book begins with an introductory discussion of free choice and the Reformed tradition and then moves on to examine the concept of freedom in the work of six early modern Reformers: Girolamo Zanchi, Franciscus Junius, Franciscus Gomarus, Gisbertus Voetius, Francesco Turretini, and Bernardinus de Moor. It will be valued by all students of Reformed theology.

Willem J. van Asselt (PhD, University of Utrecht) is associate professor in the history of Reformed theology at Utrecht University in the Netherlands and also professor at the Evangelische Theologische Faculteit in Leuven. He has written numerous articles and books on Reformed history, including *The Federal Theology of Johannes Cocceius (1603-1669)*. J. Martin Bac (PhD, Protestant Theological University) teaches classical languages in the Netherlands and is the author of several scholarly articles. Roelf T. te Velde (PhD candidate, Theological University of the Reformed Churches [Liberated] at Kampen) is the author of several scholarly articles and serves as a minister in the Reformed Church (Liberated) of Pijnacker-Nootdorp.

In both academic and pastoral circles, consideration of the subject of human "free" will or "free" choice in Reformation thought is often limited to considerations of the classic conflicts of Luther - vs. - Erasmus and Calvin - vs. - Pighius. The text of *Reformed Thought on Freedom* adds appreciably to the consideration of this topic by developing - as its subtitle states - "The Concept of Free Choice in Early Modern Theology." In this work, Willem J. van Asselt, J. Martin Bac, and Roelf T. te Velde (along with a host of contributors) provide considerable insight into the continued evolution of Christian scholarship in its understanding of the nature of human will. What is immediately refreshing is the authors' illumination of the contributions made in the works of "the guys you've never heard of": six early-modern scholars of philosophy and theology such as Girolamo Zanchi, Francisus Gomarus, and Bernardinus de Moor. In doing so, this text provides an overview of the development of the Christian thought on the subject of "free" choice from the time of Luther and Calvin to the end of the 18th century. Of particular value is the contributors' consideration of the

backgrounds (personal and academic) and relationships that connect these six thinkers with one another. The editors of the text provide a thoughtful and careful perspective of how each of these six scholars' thoughts on "free" choice maintain continuity with those of Luther and Calvin and where each of them develops new or differing insights from earlier Reformist thought on this topic. This text is particularly helpful in bridging the development of Christian thought on the topic of human will from the time of the Reformation to the early stages of the Enlightenment in Western Europe.
