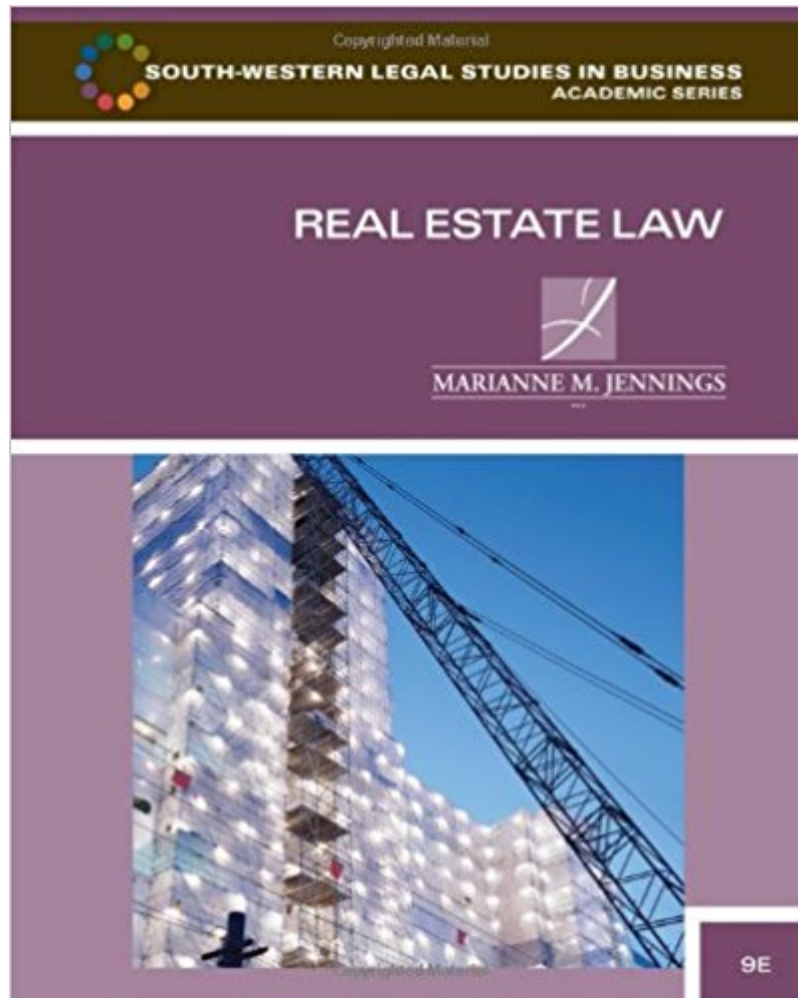

My primary reason for adopting this textbook, after having reviewed four or five other real estate law texts, was the thoroughness of the material being covered and the supporting materials in the text (cases, "Considers," chapter problems). I think the text and instructor's manual are great! The text is ideal for the student in this program. I also like the diagrams and illustrations because they help solidify the retention of the concepts being taught to the student. I would continue to use this text. She is the author of more than 200 articles in academic, professional, and trade journals as well as six

textbooks and monographs in circulation. Her biweekly column for the Arizona Republic is nationally syndicated, and her work has appeared in The Wall Street Journal. In addition, Professor Jennings is a legal commentator for National Public Radio. She has conducted more than 500 workshops and seminars in the areas of business, personal and professional ethics, legal ethics, real estate, credit management, legal issues for academic administrators, law for the CPA, and legal and political strategic planning. A member of the State Bar of Arizona, Professor Jennings earned her undergraduate degree in finance and her JD from Brigham Young University.

For a beginning reader of legal material, I was stalled in my reading process by some serious typographical errors. If a text is well written and the student understands the terms used, the material should flow. In this case it took me from 1/2 to 1 hour to make sense out of some of the text. Although most of the text is decently written, overall the book needed better editing and a decent proofreader. The instructor who used this text, although the 9th edition, told the class he planned on getting another text due to legal errors. I don't know what text he chose. Also, I wondered if this text relied at times too much on extreme cases and that this might give the student an altered perception of what is involved in many real estate cases. Some of the cases in this text were very interesting. It's possible that the 9th edition was cleaned up and therefore easier to read.

Definitely gets to the details of real estate and the various intricacies of real estate law.

This book is great! It is very informative and has real case samples. However, I am a paralegal student and the book is a bit advanced and involved for my purposes. Also it is very expensive - as most college texts are.
