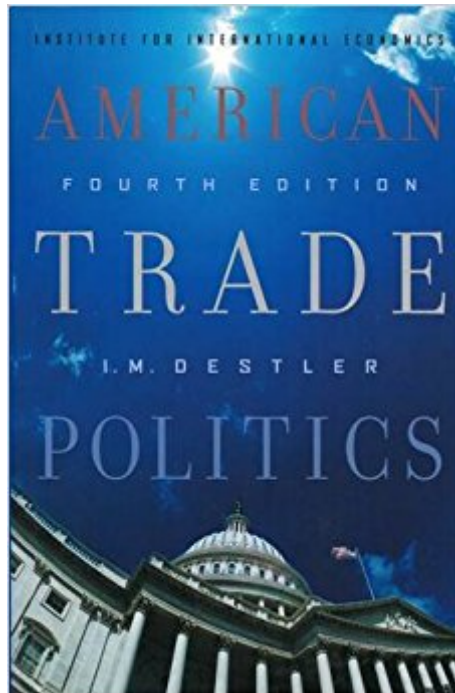

I. M. Destler has been associated with the Institute for International Economics since 1983. He is also a professor at the School of Public Affairs, University of Maryland. He was formerly a senior fellow at the Institute, senior associate at the Carnegie Endowment for International Peace (1977-1983) and at the Brookings Institution (1972-1977), and visiting lecturer at

Princeton University (1971–1972) and the International University of Japan (1986). He is the author or coauthor of 14 books on American trade politics and foreign policymaking, and US-Japan economic relations, including *American Trade Politics*, 3rd ed. (1995), *The New Politics of American Trade: Trade, Labor, and the Environment* (1999), *Renewing Fast-Track Legislation* (1997), *The National Economic Council: A Work in Progress* (1996), and *Dollar Politics: Exchange Rate Policymaking in the United States* (1989).

I feel as if the author either wrote this book in one really long, rushed sitting, or he wrote it over the course of many, many years in a fragmented process. I am a political science and economics major and I love what I'm studying, but while this book combines both of those with the historical process of American trade policy, I found myself grudgingly trying to complete this book. It's far more convoluted than it needs to be and poorly organized, with obscure references and random jumps in explanation. There has to be a better way to outline and discuss American trade policy.

I would give this 0 stars if I could. Remember the mono-tone teacher that drones on and on in Ferris Bueller's Day Off? I think he may be the author of this book because that is how stunningly boring it is.
